1. First, a look at what the Constitution says is supposed to happen as it relates to US elections.

Article II, Section 1, Clauses 2 and 3, which say:

"Each State shall appoint, in such Manner as the Legislature thereof may direct, a Number of Electors, equal to the whole Number of Senators and Representatives to which the State may be entitled in the Congress; but no Senator or Representative, or person holding an Office of Trust or Profit under the United States shall be appointed an Elector. The Congress may determine the Time of choosing the Electors, and the Day on which they shall give their Votes; which Day shall be the same throughout the United States."

- According to the Constitution, the States appoint Electors to the Electoral College.
 And the manner in which they do is 100% directed by the State Legislature. Not the Governor. Not unelected election officials. Not the secretary of state. Why?
- Because the state legislature is made up of the representatives who are closest to the people. The Founders understood that you could have a personal relationship with your local state legislator. But you might never meet the governor or secretary of state. And unelected election officials don't work directly for the people. But legislators do.
 - → The founders wisely decided that each state legislature should have their own manner of appointing electors. It doesn't have to be the same manner in Kansas as in California. Every state has their own manner.
 - → That's what scares the far-left Cabal that just admittingly stripped control of the 2020 election from the state legislatures and put it under authority of bureaucrats and courts. 



mail, we can't verify what becomes of it. Additionally, should our ballots arrive in the central aggregating location untampered, they are likely to be counted by the same computerized counters that have been proven vulnerable to error and fraud. Central counting makes fraud on a large scale easier to accomplish and harder to detect. Vote by mail cannot provide a secure chain of custody of the ballots. That means the ballots are moved without consistent public oversight, offering opportunities for fraud, mismanagement and disenfranchisement. Ballots are stored in hundreds of thousands of locations with insufficient security for two to three weeks. The ballots are handled by many anonymous persons throughout the process. It's possible that an unmarked contest on a ballot can be marked by someone other than the voter when the ballots are

- o Mail-in ballots were pretty rare before the pandemic. Now HR-1 wants to make them central for elections going forward.
- PERMANENT Mail-In Ballots are the centerpiece of HR-1. And the other stuff in there is even worse.

CASE STUDY – Kevin Freeman shares how elections work for the Cherokee Nation versus the United States:

"I'm a Native American by heritage and a citizen of a Federally Recognized Tribe. I was born on tribal lands, at least according to the Supreme Court. And I get the honor of voting in tribal elections. So, I was particularly interested in what HR-I said about Native American voting.

In Section 1904 of HR-1, the bill defines accommodations for those residing in "Indian Lands," like where I grew up. As a Native American, the state would have to provide me a mail-in ballot even without a physical address. And I would get to drop it into a drop box without an ID check or verified signature.

I guess the idea is that we Native Americans are too poor or maybe uneducated to cast a normal ballot. But I want you to contrast that with the procedure I have to go through to cast a mail-in ballot when I'm voting for the Cherokee Chief or Tribal Council.

First, they don't send me an automatic mail-in ballot. I have to register to vote and then formally request an absentee ballot. I have to prove my address. Since I live outside Oklahoma, that's really the only way I can vote. And to request a ballot, I have to submit my tribal citizenship card and then have my signature matched.

When I get my ballot, I have to fill it out properly and sign it. Then I have to place it in a special envelope that has to be notarized to prove that I am who I say I am. Apparently, the Cherokee Nation is far more concerned with election security.

Under HR-1, to vote for President, you don't need to request a ballot. You don't need to register an address. You don't need a signature match. You don't need an ID. You don't need a notary. You just take a ballot from the stack, fill it out, and drop it in an unmanned box.



How do you validate accuracy? According to the experts, you can't.

And that is just one tiny provision of HR-1."

3. Other reasons HR-1 must be stopped NOW! These should be cause for concern for all.

Highlights from the 792 page HR-1 Bill, Provided by Conservative Action Project:

- 1) HR-1 undermines the First Amendment. HR-1 undoes key Supreme Court cases that protect elections as fundamental to free speech. It would allow the Federal Election Commission to track and catalogue more of what Americans are saying, register even very small political donations, and make public those who donate to different charitable and nonprofit organizations. The legislation will subject private citizens to intimidation and harassment for their private and political beliefs, far broader than what was done in the IRS targeting scandal in 2013.
- 2) HR-1 yanks election authority away from the states. HR-1 reasserts the ability of the federal government to micromanage state elections through a process known as "preclearance." Preclearance, which was previously overturned by the Supreme Court, requires states to get permission from the federal government for changes as small as modifying the hours of an election office, or moving a voting location from a school gym to the library. Critically, none of these practices would undo any fraud or corruption. Rather, these same practices result in incorrect registrations and inaccurate voter data, while failing to address actual corrupt practices like ballot harvesting. Moreover, they are all designed to eliminate the federalism that keeps elections transparent, local, and fair.
- 3) HR-1 attacks individual voter integrity. America was founded on the principle of "one person, one vote." HR-1 turns this on its head by weaponizing every aspect of the political regulatory system. The Federal Election Commission, which is currently

a neutral body, would be given a 3-2 makeup, guaranteeing a partisan outcome with little accountability toward the actual votes which are cast. HR-1 also includes a 600 percent government match for political donations and authorizes even more public dollars to campaigns. The bill also wants to make Election Day a new paid holiday for government workers, with additional paid vacation given to bureaucrats to oversee the polls. All of these changes are designed to distance the outcome of the election from those casting their votes.

In addition, inside this Bill is a "grab bag" of new laws, regulations, and changes designed to give the Democrats permanent control of the government.

The Wall Street Journal highlights provisions designed to consolidate power for Nancy Pelosi and to change America forever.

"H.R.1 imposes California-style election rules nationwide. The bill requires every state to register voters based on names in state and federal databases—such as anyone receiving food stamps or who interacts with a state DMV. It mandates same-day and online voter registration, expands mail and early voting, and limits states' ability to remove voters from rolls. Overall, the bill is designed to autoenroll likely Democratic voters, enhance Democratic turnout, with no concern for ballot integrity. The bill also strips state legislatures of their role in drawing congressional districts, replacing them with commissions that are ostensibly independent. In practice commissions have turned out mostly to favor Democrats, as in New Jersey and California. If states want such commissions, so be it. But this is an attempt to impose one Pelosi standard from coast to coast."

Listed below Conservative Action Project put together a bullet-point summary they provided from the 792-page bill, In this report they said, HR-1:

- → Forces states to implement mandatory voter registration, removing civic participation as a voluntary choice, and increasing chances for error.
- → Mandates that states allow all felons to vote.
- → Forces states to extend periods of early voting, which has shown to have no effect on turnout.
- → Mandates same-day voter registration, which encourages voter fraud.

- → Limits the ability of states to cooperate to see who is registered in multiple states at the same time.
- → Prohibits election observers from cooperating with election officials to file formal challenges to suspicious voter registrations.
- → Criminalizes protected political speech by making it a crime to "discourage" someone from voting.
- → Bars states from making their own laws about voting by mail.
- → Prohibits chief election officials in each state from participating in federal election campaigns.
- → Mandates free mailing of absentee ballots.
- → Mandates that states adopt new redistricting commissions.
- → HR-1 would cause sweeping and irrevocable damage to the free speech, privacy, and integrity that are central components to free and fair elections in America.

The report concludes stating... "We oppose HR-1 in the strongest terms and urge all conservatives to do likewise."

o This urging was signed by nearly 150 top conservative leaders in America.

The Conservative Action Report highlighted above only scratches the surface of radical changes in the bill. We have included a few others below:

- New States Would be Added to the US It requires making both the District of Columbia and Puerto Rico new states.

Epoch Times featured an election lawyer J. Christian Adams provided these insights:

"Public Interest Legal Foundation (PILF) President J. Christian Adams couldn't believe what he was reading as he poured over the text of HR-1, the 'For the People Act,' which was the first piece of proposed legislation introduced by congressional Democrats in the 117th Congress.

- o "We have been collecting over the years non-citizen maintenance data [for state voter registration rolls], and here's how it works," Adams told The Epoch Times on Feb. 2.
- o "People apply to register to vote who are non-citizens, and sometimes they announce they are non-citizens on the registration forms. It says, 'Are you a U.S. citizen,' and they mark the box NO.' And they get registered to vote anyhow, and it's not until years later that it's discovered, and meanwhile they have been voting in American elections.'

Adams said he was stunned when he came across <u>Section 1015(D)</u>
(2) of HR-1, which makes it illegal for any government official to make a record of or to disclose publicly 'an individual's decision not to affirm his or her citizenship.'

Adams' group currently has litigation in court in Maine, Pennsylvania, Illinois, and Maryland seeking public records on individuals who were registered to vote despite indicating they were not at the time U.S. citizens. The litigation is made possible by the public records access provision of the 1993 Motor Voter Registration Act, which requires release of voter list maintenance records that indicate how individuals indicating non-citizenship were handled by voter registration officials. 'Our group is the only one in the country doing this, so I know it's directed at us,' Adams said. He pointed to the PILF report 'Steeling the Vote' as an example of the fruits of his group's litigation on the issue."

If HR-1 becomes law with Section 1501 as presently written, neither Adams nor any other American citizen will be able to obtain non-citizen voter registration records. Millions of non-citizens could vote in future elections without risk of being exposed."

- Federal Control of Voting Machines and other Election Laws HR-1 also gives
