Essential Liberties Under Assault

Our most essential liberties are under assault, including our right to free speech, right to own property, and the right to raise our children passing along our culture, morals, and values. With politicized courts and discussions of packing the courts, America's justice system is under attack.

Look at just a few of the recent overreaches by the executive branch.

- **A. Vaccine Mandates:** The big one, of course, is the vaccine mandate. Essentially, any company with one hundred employees or more will have to fire any unvaccinated individual. Is that legal? The economic dislocation is staggering.
 - You may have already seen what happened at Southwest Airlines when it's rumored the pilot staged a "sickout." Thousands of flights were grounded in a few days.
 - Hospitals, critically short of nurses and doctors, are firing medical professionals simply because they, as professionals, decided that they didn't need the COVID vaccine.
 - Now, mind you, these are the heroes on the front lines. Last year, they were heroes. Now, they're fired, kicked to the curb, and denied benefits. Maybe they survived COVID and have natural immunity. It doesn't matter. They are FIRED.

Some people want to defend bodily autonomy. Others have a medical or religious reason not to be vaccinated. The implication for our health and economy are staggering. What happens when we fire truckers or power plant operators?

We're watching a wholesale restructuring of our economy by dictatorial mandate.

"All of this (protection) is supposed to be enshrined in law, but the executive branch does not seem to care. In fact, recently, President Biden said, I know the court will disagree, but I'm doing it anyway. Biden did it to buy some time for a moratorium (on evictions), but it's wrong." –Kevin Freeman

2. The Risk of Court-packing – Most Americans get it, but does Congress? It is impossible to argue a case in a politicized court.

"Our judiciary from the very beginning was supposed to be and intended to be the nonpolitical branch of the three branches of government. You elect your executive; you elect your Legislature. But your Supreme Court and your federal judges all the way down are appointed and they're appointed for life for a reason. They should not be subject to the political whims of the populace. Their job is to interpret the Constitution and when necessary, if the political will of the nation conflicts with that Constitution, it's their job to say, "NO!" And then there are measures that people can take. You know, they can amend the Constitution if they need to." –Lathan Watts

If we keep adding judges, where would it stop?

- The Supreme Court would have to meet in a football stadium because there would be so many judges. If one side does it, the other side will respond.
- » Now they're beholden to the Constitution. Then they'll be beholden to the politicians.
- » How would you argue cases based on a court's political views?


All this was attempted in 1937 and thankfully it failed.

"It's been at 9 Justices for over a hundred years. And everybody from Justice Ginsburg or Justice Breyer to many others have said, 'You know, 9 is a good number and we should stick with it.' " -I athan Watts



ATTENTION: Of the three branches, the Supreme Court is the one most trusted. It's workable and it does shift easily, but it shifts over time. It doesn't shift immediately. And that's the problem. If you pack the court, you can change it fast.

The Public is opposed to court-packing!

First Liberty Institute put a petition available on their website that people could sign on to express their opposition to the idea of court-packing. They collected over 400,000 signatures from around the country and submitted that as part of the public comment to President Biden's commission.

Lessons in History:

Even George Washington, in his farewell address, warned against the political parties. Throughout history, we've had sort of a two-party system with those two parties pulling against each other keeping our system stable.

"Think of it in terms like a tug of war with a little flag hanging down, the flag hasn't really moved that far back and forth. Generally speaking, you know, with a few exceptions, to kind of prove the rule. And that's good. So you don't end up with radical policy shifts back and forth in a short term." -Lathan Watts

The benefit of stability is that it lets you live your life, build a business. Americans can count on certain things based on the Constitution.

The founders were very much suspicious of a pure democracy because in a pure democracy, 50 percent plus one vote can vote to take the rights away of the other 49.99 percent.



"America is seeding so much upheaval if you throw court-packing onto it, I think we will have the worst of all. We may lose all our liberties if the court were packed by this administration." –Kevin Freeman

The Founders were suspicious of democracy for that very reason because they didn't want the majority to ever be able to take away the rights of the minority.

CAUTION: You never know when your beliefs are going to be the ones in the minority. This is critical, you don't want the majority to be able to deny the rights of those in the minority.

It is because of this First Liberty Institute defends religious liberty.

You never know when it's your faith and your deeply held religious convictions that are the ones that are at odds with whatever the cultural orthodoxy is of the day on a whole host of issues.



Religious Liberty is a principle to stand to protect everybody, regardless of whatever is politically popular at the time.

3. First Liberty Defends All Religions. Why that matters even if you are not religious.

Religious freedom should matter to everyone, not matter what your beliefs. They have defended multiple denominations of Christianity as well as many religions.

We have several Orthodox Jewish clients right now. Sikhs, Hindus, Buddhists, Muslims, a Native American sweat lodge, you name it. We have defended them because, we stand for the principle of religious liberty. It is not specific to one religion.

- If the Orthodox Jewish community can't host worship in their home, then neither can anyone else.
- First Liberty defends that right for everyone because it applies to everyone and that's what the Founders intended.

The Founders didn't want there to be an official church in the United States. That's the Establishment Clause. But they wanted everybody to be able to live according to their own conscience. That's the Free Exercise Clause. Jefferson referred to religious liberty as the right of conscience.

IMPORTANT: The Free Exercise Clause is a principle that should be important even for people who aren't particularly religious. They should still care about religious liberty because, at its core, it's about living according to what you believe. And even if you're not a religious person, you likely have a set of beliefs you want to live your life by. That's what exists in protection for you.

4. A Look at Vaccine Mandates and Religious Liberty.

If politicians mandate in a way that is contradictory to the Constitution, it's the judiciary's job to say, "No, you cannot do that."

Lathan Watts shares how people of certain faith backgrounds have opposed vaccines for years.

- This particular vaccine seems to have created a lot of people studying the issue for the first time.
- » Maybe they have never really decided what their faith taught them about vaccination, but they've now arrived at a religious conviction.

Even if it's a brand new conviction, you still have the right to live according to it. And that's a well-established principle in the law that there are accommodations that must be made for people who want to live according to a deeply held religious conviction.

"It's establishing the law, but it's only establishing the law if the Court is honorable. The President could say, 'Hey, look, they've stood against my vaccine mandate, I want to force it on everybody because I've got fifty one percent of the population that elected me. And maybe they're not even behind me anymore.' His popularity has dropped. He would not get 50 percent today in an election. But this unpopular President could force a vaccine on you if the Court would allow it. That's why the last hope, the last bastion, is the Supreme Court where First Liberty does business." –Lathan Watts

The Founders created the courts, theoretically, the nonpolitical branch, so that when the people express popular will through their elected branches of government, the President and Legislature, there is a way to balance this with the Constitution.

- They wrote into the Constitution. If the people want it bad enough, they can amend the Constitution. If the Supreme Court says, "No, the way the Constitution reads, you cannot do this," and the people want it, the solution is a Constitutional Amendment.
- » That is not an easy process and there is a reason for that. We do not want this to easily be changed where it says one thing this year and something else the next.

Case study- Venezuela

This is the nightmare scenario where one party gains complete power and then they have the rulings that support whatever they want.

Venezuela and other countries have done this, politicized the court. <u>Chavez in</u> <u>Venezuela packed the court, and up until his death, they never once ruled against him.</u>

- » Venezuela was a very prosperous country before Chavez.
- The truth is Hugo Chavez grew up in poverty, and he claimed he wanted to "spread the wealth around."
- Instead, what he did to the country was destroy it.
- And not only that, but his daughter (who inherited his wealth) has \$4 billion in cash in the United States, plus however much else in investment.



» Chavez didn't spread it around; he accumulated it for himself.

"I'm concerned that we're seeing some of that here because the far left is playing for keeps. If we lose the court, we can lose all our liberties." -Kevin Freeman

Venezuela is an example of one-party rule which is scary, because then you have oneparty rule forever and always. Or, as mentioned earlier, it is also not good even if you have free and fair elections with politicized courts. You just keep shifting back and forth. You go far left, then you go far right. Each adds justices to the Court, making it huge. None of that's good.

"We've covered this on our **Playing for Keeps** (EP 111) show and briefings. I believe that there's a far-left Marxist agenda that's playing for keeps in the US. I'm not necessarily going to accuse the President of that (he doesn't seem like he's all that aware). But there are a lot of people in his party on that side, and a lot of the decisions look like they're in line with that. They are saying we're going to take this country over." –Kevin Freeman


