"They had no authority to hold them. But the longer we allow them to hang onto it, they're going to come up with more and more dangerous ideas. And so now the land that was supposed to be multiple use, sustained yield, right, timber and ranching and harvesting, and even recreation, they've now shut off all the land and they're leasing that same land... they call it conservation leasing. So, it was like the solemn promise this land is going to be just as good as if you had it under your control. In this state, multiple use sustained yield was an act that goes back into the 60s, but now they lease it to their NGO pals. They even have the New York Stock Exchange from September of 2021, allowed them to do IPOs for something called a natural asset company. So, you take the environmental asset, you tie it up, you do the IPO, and then you sell the environmental services." –Ken Ivory

Instead of allowing states to manage the land as they see fit, the federal government sends their "experts" for occasional visits. This has left much of the land unprotected from wildfires and other preventable natural disasters.



The locally managed lands are far more fruitful, provide labor opportunities for the locals, and see fewer disasters. The conservation of America's wildlife is essential, but the federal government is not the right steward of this land.

Ken has been helping Utah fight back against the federal government to claim those lands, but more

importantly, he has led the charge to fight for Utah's right to define police power.

According to the Legal Information Institute at Cornell University, Police Power is defined as "the fundamental ability of a government to enact laws to coerce its citizenry for the public good."

This power is granted primarily to the states and the people under the Tenth Amendment.

This battle commenced when the EPA, an organization not defined in the Constitution, ordered the state of Utah to shut off all coal-fired power by 2026.

"It's about the order. It's not about whether it'll work or not. And at the state level, we have a duty to make sure that we provide affordable, reliable power. It's called the police power. It doesn't mean actually just the police with the guns and badges. It means protecting health, safety, welfare, and morals. Supreme Court has said repeatedly the police powers are possessed by the states, not the federal government. So in the bill that I passed this year- was House Bill 405... we said, look, the police power is possessed by the states. Energy is central, fundamental to the police power. And so, thank you for your suggestion, But we're not shutting off the power in the state of Utah... it's very critical that people get to their state representatives, their state leaders, and give them the support that they need." –Ken Ivory

The passing of this bill provides Utah with protection from the "regulations" of the EPA as they will be able to take them up to the Supreme Court where precedent is in favor of state power.






