Efforts to pass legislation that allows gold and silver to function as legal tender in Texas and other states have been met with deceptive tactics by entrenched financial institutions and government bureaucracies.

Although supported by an overwhelming majority of Republican voters (76.5% in Texas), the bills have been derailed by last-minute “hit and run” testimonies, manipulated fiscal notes, and procedural tricks like “points of order” and delayed readings.

Even the Texas Comptroller’s office presented a false legal objection to the bill, claiming it was unconstitutional, despite clear authority in Article I, Section 10 of the U.S. Constitution.
